

Leadership Grants 2019 Purpose

The President's Council of Cornell Women established the PCCW Leadership Grants in 2000 to provide support for Cornell women by funding activities that prepare them for and/or recognize leadership.

PCCW's primary goals include:

- Expanding the role of women in Cornell's decision-making groups
- Advising the president on issues important to Cornell women
- Attracting outstanding women students, faculty, and staff to Cornell, and enhancing their leadership opportunities
- Engaging leading alumnae by strengthening their ties to each other and to Cornell
- Offering guidance and role models for Cornell women
- Providing financial support for PCCW and other initiatives that help Cornell women

In keeping with PCCW's tradition of support, the Leadership Endowment Fund was established to assist the following Cornell groups:

- Women students
- Women's athletics programs
- Women faculty, administration, and staff

Grants from the Leadership Endowment Fund are intended to:

- Support new projects which prepare and/or recognize women for leadership
- Be aligned with the university's goals and priorities as evidenced in a definitive way
- Have a reasonable probability of significant, substantive, and long-term effect
- Further the goals of PCCW



Leadership Grants 2019 Guidelines

Submission Deadline: Monday, January 7, 2019

Announcements: February 2019

Timeline for Funding

Funds will be available for expenditure after July 1, 2019 and must be used by June 30, 2020. Recipient must establish a current restricted account within the department to which funds can be transferred from the PCCW grants account.

Criteria

- Newly initiated projects that prepare and/or recognize women for leadership
- Alignment with the university's goals and priorities as evidenced in a definitive way
- Reasonable probability of significant and substantive impact
- Further the goals of PCCW

Ineligible Expenses

Co-sponsored activities may receive only one PCCW Leadership Grant per grant cycle and co-sponsors should coordinate any funding requests. In addition, the following are ineligible for funding:

- Honoraria, speaker fees, or gifts for speakers
- Alcoholic beverages
- Items to be sold for fundraisers
- Events organized to raise funds for profit or charity
- Any fee charged by participating Cornell students, employees, alumni, parents/relatives of students
