At Cornell, everyone enjoys the freedom to explore their passions, challenge assumptions, and engage with widely diverse perspectives. They also have the freedom to speak out against what they believe to be injustice, advocate for reform, or debate the ideas and beliefs of others. However, this freedom comes with a responsibility to act thoughtfully, respect others, avoid interfering with their educational experience, and contribute positively to the community.

Interim President Michael I. Kotlikoff recently said that this is an important time to "educate citizens to think for themselves, and live together; and to value truth, openness and equality as cornerstones of democracy." In your opinion, what does this mean at Cornell?

Cornell's founding egalitarian mission of "... any person ... any study" sought to educate engaged citizens from all backgrounds, melding the practical with the theoretical. We must continue to teach civil discourse, collaboration, evidence-based reasoning, and active listening. When students learn to approach disagreements with empathy and intellectual curiosity, they carry those values into their lives beyond campus. Cornell's mission is to educate principled citizens who know how to think, not what to think. By fostering a culture of intellectual openness, Cornell can champion the free exchange of ideas, to do the greatest good.
